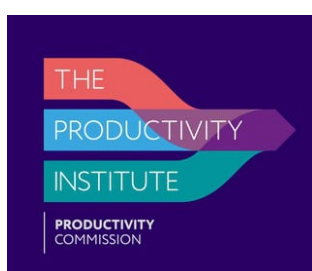

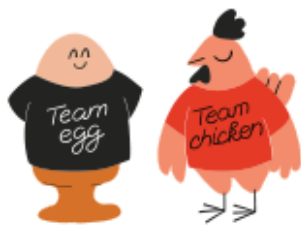


## Matthew Agarwala talks green energy on Channel 4 News
